FACTS	WHAT DOES GUARANTY PRIVATE WEALTH, LLC DO WITH YOUR PERSONAL INFORMATION
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and income • Account balances and payment history • Credit history and credit scores When you are no longer our customer, we continue to share your information as described in this notice.
How?	All financial companies need to share customers' personal information to run their everyday businesses. Who is providing this notice?	<p>This notice is provided by Guaranty Private Wealth, LLC, which is wholly owned by Guaranty Capital Corporation, and the affiliates covered by this notice are:</p> <ul style="list-style-type: none"> • Guaranty Bank & Trust Company • Guaranty Investment Corp. dba Guaranty Wealth Advisory and its subsidiary of Guaranty Financial Services, LLC • Peoples Financial Services of the Delta, Inc. • Guaranty Agricultural Credit Corporation
What we do	
How does Guaranty Bank & Trust Company protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>We assess current risks to design specific safeguards that protect customer information and have processes in place to deal with information incidents if they occur.</p>
How does Guaranty Bank & Trust Company collect my personal information?	<p>We collect your personal information, for example when you</p> <ul style="list-style-type: none"> • open an account or apply for a loan • provide account information or give us your income information • show government-issued identification <p>We also collect your personal information from others, such as credit bureaus, affiliates or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes – information about your creditworthiness • affiliates from using your information to market to you • sharing for non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	<p>Your choice will apply to everyone on your account.</p>

Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Our affiliates include companies with a common corporate identity of Guaranty Bank & Trust Company and these are listed above.
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Guaranty Private Wealth, LLC does not share with nonaffiliates so they can market to you.
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • Guaranty Private Wealth, LLC may jointly market with such companies as credit card providers and other financial institutions.

Other important information	
<p>You may have other privacy protections under applicable state laws. To the extent these state laws apply, we will comply with them if we share information about you.</p>
